OFFICIAL RULES

1. **How to Enter:** The UMCU Shop Local Give Local Giveaway begins on November 1, 2020 at 12:00 a.m. and ends December 31, 2020 at 11:59 p.m. All entries must be received by December 31, 2020 by 11:59 p.m. EST. Entries are required to be received by the following method:
 - a. **Automatic Entries: Members** – An applicant will automatically receive one (1) Giveaway entry for partnering and participating with UMCU in the Shop Local Give Local 2020 marketing campaign during the promotional period. Automatic entries must be made by 11:59 p.m. EST on 12/31/2020, in order to be eligible.
 - b. **To enter without purchase or obligation by U.S. Postal Entries:** Submit one (1) entry during the drawing timeframe. To be eligible, send a note card complete with business name, address, city, state, zip, telephone number and valid email address to the following address. Must be postmarked (by USPS) by 12/31/2020 to be entered into the UMCU Shop Local Give Local Giveaway for Local Partners. Mail to: University of Michigan Credit Union, Attn: Brand Team/Drawing, P.O. 2. **Prize Eligibility:** Officers, directors and team members of UMCU are not eligible. Also not eligible are immediate family members (spouse, parent, child, and sibling) of the aforementioned, nor any persons residing in the same household. Participation in the sweepstakes and eligibility to win Prizes is limited to legal businesses registered with the State of Michigan and/or operating within the State of Michigan.
3. **Grand Prize:** Five (5) winners will each receive one (1) \$500.

A Credit Union representative will randomly draw five (5) winners at the drawing by March 2nd, 2021. Winners need not be present to win and will be notified by phone, email, if available, and/or mail. The winner will be required to sign an affidavit of eligibility (which affirms that he/she has complied with these rules) which must be completed, signed and returned within seven calendar (7) days from date of issuance, or the Prize will be forfeited and awarded to an alternate winner. The Prize will be deposited into each winner's respective account within 3 business days after the affidavit of eligibility is completed, signed, and received by UMCU. If the winner does not have an account with UMCU, a cashier's check made payable to the legal business name will be issued. If any Prize notification or attempted notification is returned undeliverable, the Prize will be forfeited and awarded to an alternate winner. If a winner cannot be contacted within five (5) business days of the drawing date, the Prize will also be forfeited and an alternate winner will be selected.

Total Approximate Retail Value ("ARV") of Grand Prize: \$500.00. No substitutions, cash equivalents, or transfer of Prize permitted except at the sole discretion of the Sponsor, who reserves the right to substitute the Prize (or portion thereof) with one of equal or greater value, except as otherwise provided herein. Any and all other costs and expenses associated with Prize acceptance and use not specifically stated within these Official Rules as being provided, are the sole responsibility of the winner, including, without limitation, all federal, state and local taxes. Winner must abide by all Terms & Conditions of the gift cards. Prize details are at Sponsor's sole discretion.

4. **Odds:** Actual odds of winning are based upon the number of eligible entries received. Each eligible entry shall have a chance of winning is equal to that of all other entries in the Raffle.
5. **Decisions:** By entering into this drawing, entrants agree to abide by and be bound by these Official Rules, and to accept the decisions of UMCU as final. Entrants also agree to hold UMCU and each of its officers, directors, team members, members and representatives, and agents harmless from any liability arising from participation, or the acceptance of a Prize. The Parties and each of their officers, directors, team members, members, and representatives, and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance of the Prize awarded, participation in these Drawings, any incorrect or inaccurate entry information, and assume no responsibility for (i) failure of any entry to be received by UMCU (ii) theft or destruction of, tampering with, or alteration of entries and/or entry information or (iii) entries which are late, lost, stolen, damaged, illegible, unintelligible and/or postage due (or any combination thereof).
